 - Vision is meeting with Village Managers and Boards (20 members, 8 of 10 villages represented Owen Brown and Town Center not represented)
 - Went through a SWOT analysis and Q&A for the villages, took recommendations for the strategic areas
 - Met with community partners (5) Veterans, HoCo Library, ?, DTC, Merriweather Arts & Culture; 20 groups invited to take part.
 - Working with the SLT to finalize Mission, Vision, priorities and objectives
 - Incorporating all comments and the final versions will be shared at the work session on 2/1
 - Will then talk more about objectives and actions to accomplish them

 - Online feedback tool is available for people to use and provide feedback
 - Key Impacts
 - Reflects full staffing for most programs and services staffing continues to be very challenging
 - Accounts for 7% increase in HoCo's minimum wage on 1/1/2025
 - No long-term debt issuances and no use of short term line of credit are projected; may need to borrow in first part of 2026
 - Financial support for the 10 village community associations of \$7.1M, increase of \$723k

- Turning over 3 outdoor pools to independent managers as a pilot program
- Annual charge rate and cap held the same (\$0.68/\$100 of assessed valuation, 3.5% per year)

Chair Greenberg, Other Members of Columbia Association Board of Directors and the Columbia community:

I am pleased to present you with the draft operating and capital budgets for Columbia Association ("CA") for fiscal year ("FY") 2025, the 12-month period from May 1, 2024 to April 30, 2025. The FY 2025 draft budgets are the product of Board guidance, direct community engagement and significant staff initiative and effort, reflecting the community's priorities and values.

The goals of this transmittal letter are to:

- Provide a summary of the community engagement tools and process used to develop the FY 2025 draft budgets;
- Highlight the major revenue and expense factors, operational outcomes and capital spending reflected in the FY 2025 draft budgets; and,
- Share an overview of CA's current financial condition and longer-term outlook.

Community Engagement in the FY 2025 Budget Process

As we planned for the FY 2025 budget, we evaluated the FY 2024 process and the feedback we received on it, and proposed changes to the process and schedule, which the CA Board approved in July 2023.

Key elements of the FY 2025 budget process are:

- The Columbia community was again engaged directly and early in the budget process through various tools.
- The CA Board continued to have flexibility over key variables throughout the process.
- Variables such as the annual charge rate and cap and the operating budget "bottom line" parameter were not set by the CA Board as the starting point to enable the community input to more fully inform those key factors.
- Stakeholder input is being solicited online through simple interactive exercises around prioritization and ranking.
- Similarly, the CA Board discussed strategic priorities, desired outcomes for FY 2025 and community input received through
 the survey at the September 14, 2023 work session and the September 28, 2023 Board meeting (both recorded and available
 for viewing on CA's website).

The "pre-budget" materials, based on the strategic priorities selected by the CA Board in September, were presented to the community and the CA Board at the October 26, 2023 Board meeting, and an online feedback tool was opened for the community from that date through early November. A virtual community budget information session provided another opportunity for community engagement on
