- Columbia Update
 - Adopt-A-Family
 - Holiday gift drive for Community Action Council delivered gifts to families around Columbia
 - Festive Fridays
 - Snow Events
 - Preparation and snow removal by CA Open Space and teams
- Resident Speak out
 - Community Foundation distributing grants on behalf of Columbia Association
 - Participation in community planning
 - CA giving/receiving funding/grants to other non-profit organizations
 - Wilde Lake residents' backyards eroding near golf course
 - CA/Village relationship, funding going forward villages seeing reductions in funding over the last several years
- Consent Agenda
 - Approved with no discussion
- Strategic Plan
 - Discussion Topics
 - Missing metrics and goals for 5 years from now
 - Having a framework allows each Board to interpret and set goals, therefore determine metrics
 - Language and Jargon
 - Feels like the language is "stale" or "anachronistic" dated language
 - Generic terms and generalizations that are open to lots of interpretation
 - Proposal to call it the "Strategic Framework" instead of "Strategic Plan"
 - Motion to table the strategic plan and have a work session to determine goals for 5 years from now
 - Motion fails
 - Motion to rename as "Strategic Framework"
 - Withdrawn as there are references to a "Strategic Plan" in several other documents
 - Motion to include Wildlife Management in the Environmental section of the plan
 - Meant to address deer management but leave room for other invasive species
 - Motion passes
 - Vote to approve the Strategic Plan
 - Motion passes
- FY2026 Draft Operating and Capital Budget Discussion
 - There have been meetings and surveys for community participation
 - On track to approve the budget at the end of February
 - Discussion Topics
 - Reducing costs to be equivalent to what it was when Columbia started
 - Flawed comparisons that did not take into account several factors
- Board Goals Update
 - Purchasing Headquarters Building
 - Next step is to have a closed meeting to discuss
- Board Policies Review
 - John Kuchno has been reviewing 160 180 policies
 - Been created/kept since the beginning of Columbia
 - Sorted into buckets
 - Board policy (44)
 - Obsolete
 - Resolutions (not Board Policy) more Operational
 - Board Operating Procedures conduct of meetings (33)
 - Want to archive and consolidate; then have a sunset provision to let obsolete policies lapse
 - Create a "Policy on Policies" that include expirations

- Form 990 Acceptance
 - Discussion Topics
 - Officer and key employee compensation motion to recommit fails
 - Motion passes to accept the 990 as prepared
- Stonehouse Renovation
 - Motion to move money to pay for the kiln
 - There is already money in the budget for the kiln not a separate line item
 - Once the upgrade to Stonehouse is completed, the kiln will be the next thing
 - Vote to accept passed unanimously
- Overview of Capital Improvements Plan
 - Jeremy Scharfenburg reviewed the Capital Improvement Plan budget
 - Tracking all assets to determine priorities and what needs to be replaced on a cycle roofs, parking lots, machinery, etc.
- Discussion of Making Board E-mails Public
 - CA has a policy regarding emails states that Board discussions should not happen in emails
 - Board members would like to have a way to collaborate online
- Approval of Audit Committee Charter Revisions
 - Motion made to accept passed
